## PROGRAM OBJECTIVE AND SPEAKER

This program is designed to help landowners complete their income tax return for owning and/or selling timber. Basic items of income and expenses will be discussed and categorized for income tax purposes. Handouts will include copies of completed IRS forms.

**Dr. Robert A. Tufts** is an attorney and Associate Professor in the School of Forestry and Wildlife Sciences at Auburn University. He earned B.S. and M.S degrees in forestry from Louisiana State University and a Ph.D. in forestry from Virginia Tech. He also earned a J.D. from Jones School of Law, Faulkner University and a Master of Laws (in Taxation) from the University of Alabama. Dr. Tufts teaches estate planning, property law, environmental law, surveying, forest roads, and low-volume road design courses at Auburn University. His current research focuses on tax and property issues affecting forest land owners.
