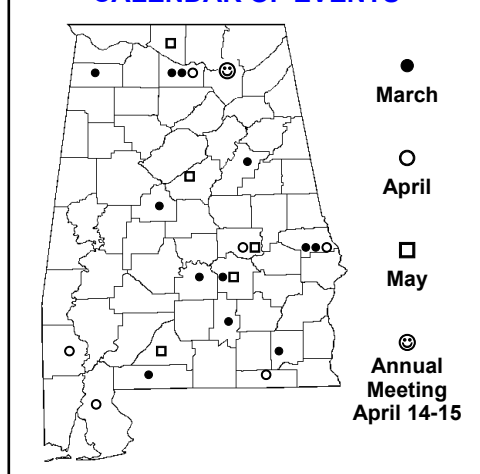

A PROPERTY TAX INCREASE



was defeated on Valentine's Day in Tuscaloosa County by about a 4 to 1 margin. About 13,000 people voted.

The proposed increases (3 mills and 5 mills) would have increased school taxes by about 80 percent.

"ALABAMA'S FOREST INDUSTRY IS STRONG due to proper timber management," reported Alabama Forestry Association CEO Chris Isaacson at a Learn and Burn last fall.



"We are currently growing more than 70% more timber every year than we're harvesting. If you take a look at how much wood we consume every year, it's right at 40 million tons," he said. "If we stopped growing trees, if everything just stopped where it is today, we could continue that \$28 billion in economic activity for 30 years. We've got an incredibly vibrant and abundant resource. That doesn't happen by chance.

"If you leave something growing on its own, it's going to eventually die. So it has to be managed. What we're doing today is one of the key tools that we have to manage those forests." Source: **Forestry celebrates women in government with Learn and Burn**, *YellowHammer News*, 10/26/22.

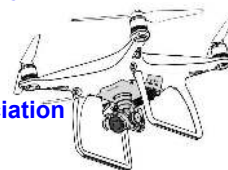
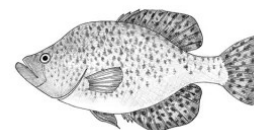

FOREST PROFILES: CONSULTING FORESTERS by Paige Townley



Ken Robertson has been a forester practically his whole life. He started planting trees when he was 12 years old. By the time he was a teen, he had his own company planting trees and cruising timber. After getting his degree in forestry from Mississippi State, he worked for another company for a few short years, but it wasn't long before he was once again running his own consultant company, **Timber Investment Managers**.

Based in Hattiesburg, Mississippi, Timber Investment Managers is focused on all things silviculture, including herbicide applications, reforestation, tree planting, and timber sales. "We are a turn-key vendor," Robertson said. "We have upwards of 10 registered foresters on staff, and we can take care of whatever is needed from start to finish."

Having been in the industry so long, Robertson has seen many changes over the years—"Thirty years ago, we weren't getting phone calls to create wildlife habitats and now we do as much of that as we do timber growth," he shared—but what hasn't changed is his love for the industry. "I love being busy and how our work never stops," he said.

"BY THE NUMBERS: More than half (55%) of forestland in Georgia is owned by private, non-industrial (or non-corporate) landowners. Studies have shown that the average cost of services provided to residential properties is \$1.19 per dollar of revenue raised. However working and open lands receive only \$0.37 on average for each dollar of revenue raised (similar returns are experienced by commercial properties). This imbalance between property types is not sustainable because while the vast majority of property value is held in residential properties, this use is being subsidized by commercial owners and working lands." *Source: Georgia Forestry, Winter 2023. While we recognize that Georgia is not Alabama, we suspect that rural forestland in Alabama pays considerably more in taxes than it receives in services. Too bad there isn't an economist at Auburn with the ability to run the numbers.*

"THIS WEEK 24 REPUBLICAN STATE ATTORNEYS GENERAL filed a lawsuit against the Biden administration's Waters of the U.S. (WOTUS) definition that was finalized in January 2023. The rule will go into effect in March; it expands the definition of WOTUS and provides most decisions to regulators allowing them to assert jurisdiction over streams and wetlands based on either the significant nexus or relatively permanent tests. The lawsuits come as the Supreme Court will decide on a lawsuit challenging the extent to which wetlands contribute to tributary networks and whether they should be subject to permitting requirements." *Source: Forest Resources Association Issue Update, 2/17/23. WOTUS is not important to most of us, until timber can't be cut or roads can't be built.*

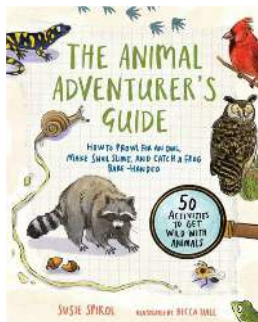
